## Membership Categories

Membership in the Alberta Student Awards Personnel Association shall be open to those individuals interested in furthering the objectives of the Association.

### 1. Full Member

- 1.1 The Full Member category shall be open to individuals from public or private not-for-profit post-secondary institutions in the area of student financial aid and awards.
- 1.2 Each post-secondary institution may send any number of members to duly constituted meetings of the Association; however, only one member per institution may vote at these meetings.

### 2. Associate Member

- 2.1 The Associate Member category shall be open to:
  - 2.1.1 individuals from public or private not-for-profit post-secondary institutions not directly involved in student financial aid and awards; or
  - 2.1.2 individuals from organizations or associations who, by virtue of their functions or interest, share the aims of the Association; or
  - 2.1.3 individuals from private for-profit post-secondary institutions who are directly involved in student financial aid and awards.
- 2.2 Associates may attend duly constituted meetings of the Association, participate in debate and serve on Association committees, but may not vote, nominate or hold office.

### 3. Corporate/Government Member

- 3.1 The Corporate/Government Member category shall be open to:
  - 3.1.1 individuals from government who, by virtue of their functions or interest, share the aims of the Association; or
  - 3.1.2 corporations and for-profit organizations who provide products and/or services in the area of student financial aid and awards and who share the aims of the Association.
- 3.2 Corporate/Government members may attend duly constituted meetings of the Association but may not participate in debate, vote, nominate or hold office.

### 4. Student Member

- 4.1 The Student Member category shall be open to:
  - 4.1.1 students enrolled at a post-secondary institution, who by virtue of their function or interest, share the aims of the Association;
- 4.2 Student members may attend duly constituted meetings of the Association, participate in debate and serve on Association committees, but may not vote, nominate or hold office.
